A MESSAGE FROM OUR CEO

Welcome to our 2023 Annual Report and thank you for taking the time to read about our frontline work. Our small team continue to respond to extraordinary demand from men and their families experiencing domestic violence across Ireland.

In 2023, our national Domestic Violence service for men supported **8,682 contacts**. These victims are men ranging in ages from 18 to 90+ years of age from every village, town and county across Ireland.

I am always conscious when reporting data that these numbers represent lives, lives of our Grandfathers, Fathers, Brothers, Sons, Grandchildren and Friends. All of these men have families who are also impacted by a widespread social issue.

Men's Aid is a trauma informed, victim centric organisation, empowering & supporting men, their children & families experiencing Domestic Violence, to be safe. Our service is underpinned by a human rights approach which strives to ensure that all of our engagements are non-discriminatory in nature and in accordance with our National Strategy, 'Zero Tolerance', lead by the Department of Justice.

What are we listening and responding to?

- Men disclosing emotional and psychological abuse, constant verbal abuse, belittling, name calling, insults, having their confidence chipped away at, hurtful comments. Partners telling men they are useless, being told they don't earn enough, being told they are bad dads, threats of calling the Gardaí with false allegations of abuse/violence, threats of parental alienation, parental alienation, and access issues.
- Men telling us of financial abuse, that they have little or no access to money, men given a weekly allowance, their pin/online banking passwords known to his wife who withdraws money from their account, transfers money from his account to hers without agreement, men with physical injuries from kitchen items used as

weapons to harm them, a client who presented to us with visible stitches on his face, also telling us of the kicks and punches they received regularly from their wife.

- Our clients in both heterosexual relationships and same sex relationships who disclose sexual assault.
- Men staying in the abusive home as they have no accommodation options to escape to/they don't want to leave the children in the home with the abuser.
- The thousands of disclosures that are visible and invisible, some leaving lifetime scars.

Tackling the issue of domestic violence is a collaborative effort. We are committed to working closely with other services including An Garda Síochána, Tusla, the Department of Justice, frontline professionals, medical and health professionals, social workers, and the wider NGO services working across DSGBV. We are working towards the day when the needs of all victims are supported, everyone is safe, and perpetrators are held accountable.

Finally, I would like to take this opportunity to thank all of our funders, donors, supporters, NGO colleagues, and statutory and non-statutory allies. My thanks go to our very small team, without whose commitment, passion and professionalism, we would not be changing and saving the lives of thousands of men across Ireland.

My thanks to our voluntary Board members who each give their time, experience and expertise to the organisation and to myself. I am always conscious that time is the most precious commodity. As we are a small team, my role is very proactive and time sensitive, and I am very grateful to have a supportive Board to help me in my position as CEO. It is hugely appreciated.

5. Our academic research partnership with Trinity College Dublin

In 2023 Men's Aid partnered with Trinity College Dublin to produce evidenced based, academic research. The Irish Research Council provided funding. Lead by Dr. Melissa Corbally, Assoc. Prof. TCD, the research was presented at the European Conference of DSGBV in Iceland and again at a Canadian Conference on DSGBV. Men's Aid data was the only data shared to represent the experience of male victims in Ireland.

Due to our small team and very limited resources in 2023 we focused on four specific national campaigns to support:

We were proud to welcome again for the third consecutive year Minister for Justice, Helen McEntee TD, to our offices to formally launch our Annual Report on IMD 2023. We also were delighted to welcome Dr. Melissa Corbally of TCD, as our keynote speaker. We thank the Minister McEntee and her department for her continued support of our work.

Training (Internal & External)

We recongise the importance of ongoing internal and external training for all the team. In 2023, we focused on trauma informed and suicide awareness training. We also launched our **Practitioner's Guide** and provided a training day to go through the guide in detail. All other mandatory training such as *Children First, Safe Talk, Assist* was also completed. Our CEO completed the Law Society, Certificate in Charity Law, Trusteeship and Governance.

All the team at Men's Aid are Trauma Informed trained.



Male = 6,319


